The silver lining to loadshedding however is that it has spurred a much more engaging and responsive government as well as accelerated private sector investment in energy.

The business government partnership across Energy; Transport and Logistics; and Crime and Corruption, led by Business for SA is gaining momentum. A third in person meeting between the President and key Ministers and business was held with continued focus on the critical path to end loadshedding and fundamentally reform the sector. There is increasing confidence in the Energy Action Plan as a pathway to navigate the energy crisis and end loadshedding.




The Energy Council is leading the energy coordination work on behalf of business with nearly 130 business volunteers working across five key workstreams with Eskom.


